

Commercial Licence Agreement for Meyvn

This is your licence agreement that allows you to download, install and/or use Meyvn on the terms set out below in this licence. If you download, install and/or use Meyvn you have accepted these terms. If you do not wish to accept these terms, you should not download, install, or use Meyvn.

1 Parties

"Sapiens Sapiens" refers to Daniel Szmulewicz, "osek morshe" incorporated in Israel with registration number 011902855.

"You" are an incorporated entity downloading, installing and/or using Meyvn, or authorising your employees and/or contractors to download, install or use Meyvn on your behalf.

2 Definitions

"Meyvn" means the software known as Meyvn and the documentation associated with the software.

"Licence Certificate" is evidence provided to you by Sapiens Sapiens of your licence purchase.

"User" is any employee, contractor or other worker authorized by you to use Meyvn while performing duties within the scope of their employment or assignment.

3 Copyright Ownership and Grant of Licence

Sapiens Sapiens is the owner of all copyright and intellectual property rights in Meyvn and grants you a personal, worldwide, royalty-free, non-assignable

and non-exclusive license to use Meyvn under the terms and conditions contained in this licence until the licence is terminated for any reason.

4 Customer Obligations

A Licence Certificate allows a single user to use Meyvn at a time.

You must ensure that no more than one user uses a given Licence Certificate concurrently.

If multiple users use a single Licence Certificate you must purchase sufficient extra licences to cover the number of users.

5 Evaluation Period

Users may use Meyvn for evaluation purposes without charge for a period of thirty days from the date of installation.

When the evaluation period expires, you must obtain a License Certificate for continued use of Meyvn or stop using Meyvn.

6 Intellectual Property

Sapiens Sapiens owns and will retain all legal rights in the software, including all copies, alterations, derivatives or modifications of Meyvn; whether in whole or in part.

Meyvn is licensed, not sold.

7 Upgrades

You will receive any upgrades to Meyvn during the initial one year period after your purchase free of charge.

Sapiens Sapiens is not obligated to provide upgrades during the update period, even if you have requested fixes or changes to be made.

Sapiens Sapiens will make all efforts to ensure that upgrades are of high quality, but will not be liable if changes cause you losses or damages.

8 Liability

The use of Meyvn is at your own risk.

To the maximum extent allowed by law, Sapiens Sapiens will not be liable to you in any way for any damages to you or any third party resulting from your use of Meyvn. If Sapiens Sapiens would nevertheless be held liable by a competent court, then its liability shall be capped at the license fee paid during the past 12 months or, in the absence of a paid license fee, 50 ILS.

Sapiens Sapiens does not guarantee that Meyvn will meet all of your requirements, or that any errors in Meyvn will be corrected.

9 Modifications

If Sapiens Sapiens is required to change these terms, you will be advised of the changes and you will have the option to terminate your licence if you do not wish to accept the new terms. However Sapiens Sapiens will not reimburse your licence fee in whole or in part if you choose to terminate your licence.

10 Termination

Sapiens Sapiens may terminate your licence to use Meyvn at any time if you breach any terms of this licence and fail to rectify the breach within 7 days of being notified by Sapiens Sapiens.

11 Jurisdiction

These terms are subject to the laws of Israel.

You are subject to the exclusive jurisdiction of the High Court of Israel for any matters arising directly or indirectly from these terms.
